3. HAZARDS IDENTIFICATION:

Xi Irritant, N Dangerous for the environment.

4. FIRST-AID MEASURES:

Inhalation: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

5. FIRE FIGHTING MEASURES.

Extinguishing media Use CO₂, Dry Powder or Foam type Extinguishers, spraying recommended: extinguishing media to base of flames. Do not use direct water jet on burning material.

Special measures: Avoid vapor inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.

6. ACCIDENTAL RELEASE MEASURES.

Cleaning up methods Remove all potential ignition sources. Contain spilled material. Cover for spillages: with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.

7. HANDLING & STORAGE.
